I DO HEREBY RELEASE Humble Boxing Academy and its directors, officers, employees, sponsors, independent contractors and agents from all liability, and DO HEREBY WAIVE as against Humble Boxing Academy and its directors, officers, employees, sponsors, independent contractors and agents all recourses, proceedings, claims, and causes of action of any kind whatsoever, in respect of any and all personal injuries or property losses which I may suffer arising out of or connected with my preparation for, or participation in Boxing & Fitness not with standing that such injuries or losses may have been caused solely or partly by the negligence or breach of duty of Humble Boxing Academy or any of their directors, officers, employees, sponsors, independent contractors or agents.

#### I HEREBY ACKNOWLEDGE AND AGREE THAT: 2.

- Boxing & Fitness may be dangerous, exposing participants to many risks and hazards, some of which are inherent in the very nature of Boxing & Fitness itself, others which result from human error and negligence on the part of the persons involved in organizing, staging and/or operating the Boxing & Fitness;
- as a result of the aforesaid risks and hazards, I as a participant may suffer serious personal injury, even death, as well as property loss;
- some of the aforesaid risks and hazards are foreseeable, but others are not;
- I nevertheless freely and voluntarily assume all the aforesaid risks and hazards, and that, accordingly, my preparation for, and participation in Boxing & Fitness shall be entirely at my own risk;
- I understand that neither Humble Boxing Academy nor any of its directors, officers, employees, sponsors, independent contractors or agents assume any responsibility whatsoever for my safety during the course of my preparation for or participation in **Boxing & Fitness**

- I clearly understand that Humble Boxing Academy would not permit me to participate in Boxing & Fitness unless I signed this RELEASE and WAIVER of LIABILITY AND ASSUMPTION of RISK AGREEMENT, that this RELEASE and WAIVER of LIABILITY AND ASSUMPTION of RISK AGREEMENT applies Boxing & Fitness whether occurring in the near or distant future, and that the terms of this Agreement have been explained to me by Humble Boxing Academy or one or more of their representatives;
- this RELEASE and WAIVER of LIABILITY AND ASSUMPTION of RISK AGREEMENT is binding on myself, my heirs, my executors, administrators, personal representatives and assigns;
- this Agreement may be in addition to another agreement I must sign as a condition of
  participation in Boxing & Fitness and that I am bound by the terms and conditions of
  both agreements; and
- I agree that I am physically capable of participating Boxing & Fitness, and that I have no
  pre-existing conditions that would hinder my ability to participate in Boxing & Fitness
  Activities.
